Meals are not provided as part of the vendor participation fee; however, we invite our vendors to participate in our Saturday, April 7, 2018, luncheon and/or banquet to not only hear our guest speakers, but to network with our conference attendees. The **luncheon** is a Mexican Buffet, which includes Beef enchiladas and tacos with pico de gallo, cheddar cheese, sour cream, shredded lettuce, diced tomatoes and guacamole.
